- 7.1 Understanding the Multi-levels of Government "Indigenous Population"

L. McDonald provided a PowerPoint presentation the Board of Directors on Understanding the Multi-Levels of Government, Indigenous Population. Outline of the presentation included;

9. Chief Executive Officer Report

9.1 October CEO Report to the Board – Executive Summary

M. Ellis, CEO, provided a high-level executive summary overview to the Board, highlights included:

- On February 17, 2023, Health Minister Audrey Gordon announced that the Manitoba government is investing over \$123 million in nine initiatives to retain, recruit and support nurses building on its commitment to end mandated overtime and add 2,000 health-care professionals through the Health Human Resource Action Plan.
- On February 16, 2023, 2 Clinical Team Mangers form the IERHA joined the Manitoba delegation and left for the Philippines. We have been allocated 20 positions (LPNs, RNs and HCAs) with the possibility of adding more Health Care Aide (HCAs).
- On January 31, 2023 the CEO attended the Assiniboine Community College hosted a celebration luncheon at its rural rotating Practical Nursing training site in Arborg.
 - The site acknowledged the former LPN nursing graduates and welcomed the second intake that started in September 2022.
 - Since 2010, Assiniboine has offered the Practical Nursing program over ten times in the Interlake-Eastern region in Ashern, Selkirk, Pine Falls and Arborg.
 - Practical Nursing is the largest single program of study at Assiniboine, with 100 per cent of graduates surveyed reporting they had jobs. Since 1975, more than 4,200 individuals have graduated from nursing programs offered by the college.
- The IERHA staff welcomed SAFE Work Certified Auditors Jacques St. Hilaire, Canadian Registered Safety Professional (CRSP) – Lead Certified Auditor; Michelle Gawronsky, Certified Auditor; and, Quim Reis, CRSP – Certified Auditor. The auditors were at IERHA corporate office February 13 to 17, 2023 and then will be heading out to facilities for the week of February 20 to 24, 2023.
- On Monday, February 13, 2023 we launched a staff racial climate survey, asking our staff to complete the 10 to 15-minute survey. The survey will remain open until Friday, March 3 at 11:59 p.m.
 - The survey includes questions about incidents of racism you may have experienced personally or witnessed in your workplace. Information you provide is anonymous, and it is grouped for a third party to provide data analysis so your identity will never be known.

- The information you provide will help in developing approaches to disrupt racism in Manitoba's health-care system; create safer health-care environments for patients, families, staff, physicians, volunteers, and learners; and improve health outcomes for patients who are from Indigenous, Black, and Racialized populations.
- The Manitoba government will also provide funding for 40 new undergraduate physician-training seats, a 10-seat increase in the one-year international medical graduate program and 30-seats in the two-year postgraduate medical education program for internationally educated medical students.
 - This funding will ensure access to undergraduate medical education programs will keep pace with Manitoba's population growth, while supporting a sustainable and growing number of physician graduates able to work in the province's health-care system.

The February 2023 fulsome CEO Report to the Board on progress was included in the package.
